SL Tip of the Month - Custom Reporting in Dynamics SL

Are you having issues with custom reports after upgrading to Dynamics SL 2011? Here are a few items listed below

to try:

Remember to set the DataSource Location. Use the steps below:

1. Open the Report in Crystal Reports
2. On the Database menu, click Set Datasource Location
3. In the Replace With box, expand Create New Connection , and then expand ODBC (RDO)
4. Click your Microsoft Dynamics SL database, and then click Next
5. Enter your log on information. Do not select the Trusted Connection check box
6. Click Finish
7. Click the database in the Replace With box. Then, click the database in the Current Data Source box
8. Click Update
9. If you have multiple databases in the Current Data
10. Source box, repeat steps 8 and 9 for each database
11. Click Save , and then exit Crystal Reports
